**NURSERY ADMISSIONS APRIL – 2024**  
**(Only open to Property Owners of Magarpatta City)**

1. This Notice deals only with Nursery Admission. Admissions will be in accordance with the Maharashtra Right of Children to Free and Compulsory Education Rules 2011.  
The Age Limit for the Nursery Class is 3 to 4 years as on 31<sup>st</sup> December 2024.
2. The Property Owners of Magarpatta City are given the First Preference. ONLY CHILDREN OF PROPERTY OWNERS ARE ELIGIBLE FOR ADMISSION. PROPERTY OWNERS CANNOT SEEK ADMISSION FOR THE GRANDCHILDREN IF THEY ARE NOT RESIDING WITH THEM. THEY WILL HAVE TO PRODUCE AN AFFIDAVIT IN CASE THE GRANDCHILDREN ARE STAYING WITH THEM.
3. Influence or third party intervention in any form shall disqualify your Child's admission with immediate effect.
4. THE SCHOOL DOES NOT ACCEPT DONATIONS FOR ADMISSION IN ANY FORM. Please refrain from making payments to any individual or group to help secure a seat in our School. Anyone indulging in such practices will not be granted admission and the School will not be held responsible if you are duped.
5. REGISTRATION FOR ADMISSION TO THE NURSERY FOR 2024-25 WILL TAKE PLACE IN THE MAIN SCHOOL (OPPOSITE DESTINATION CENTRE) on Saturday, 06.01.2024 between 11:00 a.m. and 1:00 p.m. and on Monday, 08.01.2024 between 4:00 p.m. and 5:00 p.m.  
The Non Refundable Registration Fee is Rs.1000/- (Rupees One Thousand Only). It has to be paid in cash at the time of Registration.
6. THE LUCKY DRAW WHICH CONFIRMS THE ADMISSION AND IS COMPULSORY UNDER THE RTE ACT WILL BE HELD ON SATURDAY, 13.01.2024 at 11:00 a.m.
7. Please note that the School cannot admit Students having Special Medical Problems which require Special Schools and Specially Trained Teachers and Assistants.
8. At the Time of Registration the Parents must produce:
  - a) The Original Birth Certificate of the Child and a Copy of the same. **Birth Certificate with the Child's name - from a Municipal Council/Corporation. (Certificate issued by Hospital will not be accepted)**
  - b) A Certificate from the Senior Vice President (Administration) of Magarpatta City that the Parent is a Bonafide Property Owner of Magarpatta City.
  - c) **THE AADHAAR CARD OF BOTH THE PARENTS AND CHILD IS COMPULSORY. CHILD WITHOUT AADHAAR CARD WILL NOT BE REGISTERED FOR THE ADMISSION.**
  - d) Latest postcard size Family Photograph (Formal) of father, mother and Child together, preferably taken in the Studio.
  - e) Parent's and applicant's individual photographs.Registration Fees of Rs.1000/- (Rupees One Thousand Only) in cash.


